RESEARCH INTERESTS

My research interests are in the areas of industrial relations, labour law, occupational health and safety (OHS) and labour migration, in a historical and international perspective. During the past two decades, my studies have focused on trends and developments in Sweden and in the EU in the light of long-term structural changes in the organization of production and work, political change, and increasing internationalization of the labour market. My projects have concerned (1) precarious employment, especially false (bogus) self-employment and other phenomena in the 'grey area' between subordinate employment and genuine selfemployment: (2) east-west labour migration, industrial relations and labour standards in the EU (3) EU supported labour market projects for social inclusion and cohesion; (4) structural and intersectional perspectives on working conditions in tax-financed elderly care exposed to private competition; (5) structural and intersectional perspectives on threats and violence in working life; and (6) recent trends in public sector industrial relations in a Swedish and European perspective.
